## **The London School of Economics and Political Science and Palgrave Macmillan announce partnership to publish *BioSocieties***

Palgrave Macmillan, the academic publishing division of Macmillan Publishers Ltd, and The London School of Economics and Political Science (LSE) announced today that Palgrave Macmillan will publish *BioSocieties* on behalf of the LSE.

*BioSocieties* is an innovative peer-reviewed research journal, which explores the social, ethical and policy implications of developments in the life sciences and biomedicine.
